- Complete Annex 13A IN FULL and return it as soon as possible to resourceaccounts2019@mycsp.co.uk
- Respond to any queries as soon as you can, as it affects the turnaround of your deadline dates.

Active data cleanse – will you complete on time?

As the Data Cleanse project nears the end, please make sure you're on track to complete by the predicted date.

To do this, check your Active Data Cleanse MI to see if your validations are being cleared at the required rate.

Also, please remember to fix your monthly errors and warnings. Failure to do so may lead to an increase in Data Validation Failures (DVFs) and missing or incorrect data on member records!

Switch on to safer emails

From the **1st of April**, the Scheme Administrator (MyCSP) will be using an email encryption system to make email exchanges more secure

To use the new system, you must confirm to the Scheme Administrator that you've turned on TLS 1.2. To do this, simply speak to your IT department or shared service provider.

Email your confirmation (or advise if TLS 1.2 is not turned on) to **systemsservicedesk@mycsp.co.uk** as soon as possible.
