Casuals/Fixed Term Appointments (FTAs) employed after 30 July 2007 and whose contracts are subsequently renewed

From 30 July 2007, both casuals and FTAs had the same pension choices. Where you offer them a further or new contract you must follow the actions given in the scenarios below. The action you take will depend on the length of further employment you are offering and whether or not the casual/FTA joined/remained in the CSP arrangements in their first period of employment. Please note that if you are simply making use of flexibility in the original contract to extend the period of employment, there is no action for you to take.

Casual/FTA (who has already joined a scheme)

Where a casual/FTA joined **alpha**, **nuvos** or **partnership** during the course of their original employment, they will continue to be a member of that scheme. If the casual/FTA joined prior to 1 April 2015 and were enrolled into **nuvos**, they would have moved into **alpha** from 1 April 2015 and will continue in that scheme (unless they qualified for full protection or tapered enrolment – see section 4.1.18 of the Employer Pension Guide for further information).

You must use letter text N below.

Casual/FTA (who chose not to join the arrangements at the beginning of their original employment)

If the casual/FTA had opted out of **alpha/nuvos** and also did not open a **partnership** pension account, they will remain opted out of the Civil Service pension arrangements until they are automatically enrolled, decide to opt into the CSP arrangements or open a **partnership** account.

You must use the letter text O below.

You should not treat the employee as a new entrant and, should the member request to opt into the pension scheme, you should follow the usual opt in process and inform the Scheme Administrator (MyCSP) accordingly.

For

- FTAs in post before 30 July 2007 who are either a **premium** member or have a **partnership** account and are offered a further or new contract of employment at some point after 30 July 2007 (and there is no break between employments).*

If the further or new contract is after 1 April 2015 the member may have since moved into **alpha.*

- Casuals/FTAs whose current contract of employment began on or after 30 July 2007 who are either a **nuvos** member, were a **nuvos** member and have since moved into

alpha or have a **partnership** account and are offered a further or new contract of employment (and there is no break between employments).

- Casuals/FTAs whose current contract of employment began on or after 1 April 2015 who are either an **alpha** member or have a **partnership** account and are offered a further or new contract of employment (and there is no break between employments).

Pensions

You are already covered by the Civil Service pension arrangements. We will continue to deduct contributions from your salary, if applicable, in the usual way.

For casual/FTAs whose appointment began on or after 30 July 2007 who opted out of **nuvos**, do not have a **partnership** account, and are offered a further or new contract of employment (and there is no break between employments).

For casual/FTAs whose appointment began on or after 1 April 2015 who opted out of **alpha**, do not have a **partnership** account, and are offered a further or new contract of employment (and there is no break between employments).

You previously opted out of the Civil Service pension arrangements and chose not to join **alpha** or to open a **partnership** pension account. Unless you tell us otherwise, you will remain opted out. However, please note that, The Pensions Act 2011 requires all employers to automatically re-enrol all workers who are not currently in a qualifying pension scheme periodically (usually every three years), from the employer's staging date.
