Removal of Leaver Notifications



YOU SAID... you wanted us to streamline processes undertaken by employers to administer the scheme.

Request for Services (RFS) form to us when notifying us of a resignation.

Resource Accounts fact gathering activity




It's approaching that time of year again when as an employer, you're required to return your Annual Resource Accounts.

Please keep an eye out for the annual EPA renewal letters. These will provide you with details of any actions needed, and you will need to ensure that your payroll, payroll provider is aware of this and any actions they need to take.

The Enhanced Effective Pension Age (EEPA) renewal letters will be distributed in March 2019 to employers with eligible members.

Employer Pension Notices (EPNs)




In the last three months, we've issued 11 EPNs (EPN552 - EPN563) about various issues. The EPNs outline updates such as the publication of the new 2019 Scheme Year Planner, removal of Leaver Notifications for some employers and the fact-finding mission on resource accounts as previously mentioned.

Enhanced email security



Care Year End (CYE) & Pension Input Period (PIP) deadlines



Deadline dates will be aligned with your agreed May 2019 interface submission. Your interface analyst will send the deadline dates to you and discuss them.

Rectification of Guaranteed Minimum Pension (GMP)



As the GMP reconciliation exercise draws to a close, we will start to recalculate pension benefits for affected pensioners early in 2019. These pensioners will receive a letter explaining when the change to their pension will take place and how it will impact the pension they receive. It is expected that all affected members will receive a letter by the end of September 2019.
